Dear Fellow Alumni:

The Silliman Alumni Association Inc. (SAAI) is pleased to announce the opening of nominations for the 2021 Outstanding Sillimian Award (OSA).

For the guidelines and requirements, please visit the OSA page of the SAAI website, [saai.org.ph](http://saai.org.ph). In addition, please be informed that the SAAI Board of Directors are implementing the following updates/innovations to the administrative handling of OSA nomination documents to address freight and handling concerns brought about by the COVID-19 pandemic and to address concerns on the environmental footprint of the OSA documentary process:

1. It is no longer necessary to submit the nominee's curriculum vitae (CV).
2. A scanned copy or image file of a 2x2 identification picture against a white background is required.
3. All OSA nomination documents shall be submitted in PDF searchable files.
4. A maximum limit of 1,000 words for each testimonial from 3 disinterested persons.
5. To avoid duplication, **only** the endorsing chapter shall submit the completed OSA documents to [alumni\\_associaton.office@su.edu.ph](mailto:alumni_associaton.office@su.edu.ph).
6. The deadline for submission of complete documentary requirements shall be strictly implemented; and hence, no additional documents will be accepted after the deadline.
7. Documentary Technicalities – Portfolio Size (maximum limit of 30 pages), Uniformity and Conciseness – Use short bond paper size **only**; Use Font Type = Arial; Font Size = 10.

Further, please be reminded that the following cannot be nominated for the 2021 OSA:

- a) incumbent officers and/or board members of the nominating and/or endorsing chapter; and
- b) incumbent National Officer or Director of SAAI.

The deadline for submission of nominations is **12 midnight of October 31, 2020**.
