3. The testimonial, from three (3) disinterested persons, not related within the 6<sup>th</sup> civil degree by reason of consanguinity or affinity to the nominee, **should be duly signed and dated and shall not exceed two pages.**
4. To avoid duplication, only the nominating or endorsing chapter shall submit the completed OSA documents to [saai@su.edu.ph](mailto:saai@su.edu.ph), Attention: OSA Committee.
5. The deadline for submission of complete documentary requirements shall be strictly implemented; and hence, no additional documents will be accepted after the deadline.

Further, please be reminded that the following cannot be nominated for the 2023 OSA:

- a. Incumbent officers and/or board members of the nominating and/or endorsing chapter and
- b. Incumbent Executive Officers or Trustee of SAAI.

The deadline for submission of nominations is **5:00 pm, PhST of 30 November 2023.**
